## From the President's Team

#### Dear Members and Readers,

At the outset, I pray that may Lord Ganesha bless you all with good health, happiness and prosperity.

We have just concluded celebration of Gowri Pooja and Ganesh Chathurthi. The Bhadrapad month started with this celebration of Gowri – Ganesh Pooja and will end with Mahalaya Amavasya.

You may all be knowing that Mahalaya Paksha is a deeply sacred 15 days period for us, which is dedicated to honoring and remembering our ancestors. We all believe that during this time, the souls of ancestors visit earth. Performing rituals helps them attain liberation. It is a time to resolve karmic imbalance caused by neglected ancestral duties. According to legend, KARNA, the great warrior from Mahabharata, donated gold instead of food during his life. In the afterlife, he was given gold but no food. He was allowed to return to Earth during this period to make amends by offering food to the poor and ancestors.

Mahalaya Amavasya – This day is especially significant where it marks the spiritual awakening of Goddess Durga and starting of Durga Pooja. The following day of Mahalaya Amavasya, the Navaratri Celebration starts with Shri Devi Ghata Sthapana.

Navaratri is one of the most vibrant and spiritually rich festivals, which is celebrated over nine nights and ten days to honour the divine feminine energy – Goddess Durga in various forms. It celebrates the victory of good over evil and the power of Shakti, the divine feminine force. Each of these nine days is dedicated to a different form of Durga, representing various virtues – viz. 1. Purity and Strength, 2. Penance and devotion, 3. Courage, 4. Creativity, 5. Motherhood, 6. Valour, 7. Destruction of Evil, 8. Wisdom and Peace and 9. Fulfillment and Perfection. The 10th day which is Vijaya Dashami, is when we celebrate Durga's victory over the demon Mahishasura. Which is also a day Lord Rama had victory over Ravana. From the spiritual, now I will move towards other areas.

Many economists have predicted that India's economy will remain robust, with high-frequency indicators showing sustained momentum. The New Income Tax Bill 2025 which is passed by Parliament will replace the six-decade old Income tax Act, 1961 which will come into force from 1st April, 2026. Though it is stated that it does not impose any new tax rates and it is simplified in language, one needs to study its impact on the common man / middle class Indians. A lot of investments in AI and semiconductor manufacturing is in process. Despite the US's imposition of high tariff on Indian exports, the India Leadership remains confident and it has affirmed that it will act in the national interest. Our Government is pushing for sector-wide collaboration in energy transition, AI and digital infrastructure.

## Personal Financial Planning with FinTech solutions

Personal Finance is the important activity in one's Working Life Span to manage the earned income efficiently with appropriate investment in well diversified Asset class for achieving Life's Goals and creation of Wealth.

Personal Financial Planning is a systematic process with the following factors:

- 1. Budgeting
- 2. Financial Goals
- Asset Allocation
- 4. Portfolio Review
- 5. Deployment
- 6. Risk Management
- 7. Wealth Creation
- **1. Budgeting:** It is the most important factor to be considered in Managing Personal Finance. It involves analysis of Income, Expenses and Surplus Funds. for Investing in Financial Assets for achieving the specific Goal in life.

Recent RBI report on Financial Stability expresses concern about Household Savings dipping to 5.3% of GDP, Lowest in 47 years. Household Debt has also almost doubled in last 10 years.

This is due to shift in mind set from Saving to Spending, ease of borrowing for non- productive, depreciating assets. Budgeting for household expenses should be on the basis of saving and investing in productive assets.

Household expenses should be managed from the amount after setting aside Savings from Income. A 50- 30 - 20 Rule in Budgeting is useful for Managing Money efficiently.

**2. Financial Goals**: We have multiple aspirations in life and they need to be realised during the Working Phase of our life. However, a well planned and Identified, S.M.A.R.T Financial Goals, are the key to deploying our Savings in properly chosen Financial Instruments to achieve the milestones.

Financial Goals have to be Specific, Measurable, Attainable, Realistic and Timely for informed decision in investing.

**3. Asset Allocation :** Where and how one should invest his/her Saving/Surplus funds in Financial Instruments to realise the Goals efficiently, is based on Asset Allocation.

There are different Asset Classes with its characteristics like yield, risk adjusted return, investment horizon, liquidity, taxation etc.

Broadly the Asset Classes are:

- Fixed Income
- 2. Debt
- 3. Equity

- 4. Commodities
- 5. Gold, Silver

Depending upon the Investor's Goals, asset allocation is done based on Financial Analytics, Risk Management to build the Portfolio.





#### Why is the Flag hoisted on Independence Day?

The phrase "hoisting" is used on Independence Day because the flag is raised upward from the bottom of the pole. This action represents liberation from colonial control, patriotism, and the emergence of a new nation. On Independence Day, flag hoisting is frequently a ceremonial occasion in which the national anthem is played

while a military or civilian honour guard raises the flag. This symbolic action marks the end of colonial rule and the emergence of a new nation, igniting feelings of patriotism.

#### Why is the Flag unfurled on Republic Day?

Republic Day commemorates the 1950 adoption of the Indian Constitution. On this occasion the flag is "unfurled" rather than hoisted because it is uncovered without being raised, having begun its life at the top of the pole folded. This act demonstrates the shift from colonial control to an independent, democratic republic and demonstrates the dedication to the values outlined in the Constitution.

## A Saga of toil



Dr. Karishma Hemmady of Saraswat Colony Santacruz had adorned herself with the prestigious Indian qualifications of MBBS & MD in Dermatology. She wanted to carve her own career path and soar higher, so she spread her wings and took flight for the United Kingdom in 2018.

With this Specialist Registration, she was elevated in her NHS Hospital to the highest level of Medical Consultants in UK, called "Substantive Consultants".

In her quest for further academic growth, Karishma enrolled for Master's Degree in Law from the prestigious "University of Maryland" USA. Equipped with the Law degree and her medical qualifications, she earned a position as a Consultant to Legal Offices dealing in Medicolegal cases relating to Dermatology.

In view of her exemplary academic and professional achievements, The General Medical Council [GMC] of UK awarded her with the "Fellowship of the Royal College" of London [FRCP]. This prestigious award by the Royal College of Physicians, London, in 2024, is an acceptance into the elite group of Physicians with exemplary achievements.

Karishma has presented articles and papers in numerous major International conferences in Dubai, Vancouver, Melbourne, USA and London.

Dr. Karishma has a very successful practice as a Consultant Dermatologist at the famous Harley street in Central London.

The latest feather in her cap is being appointed as "Principal Dermatologist to Goldmann Sachs" in UK.

Karishma's path was riddled with challenges, such as navigating unfamiliar UK healthcare system, fulfilling licensing mandates, overcoming cultural barriers, and battling traumatic homesickness. Her resilience helped her overcome hurdles and emerge a winner.

Her father, Dr. Dileep Mangesh Hemmady, a Dermatologist of high repute in UAE, mother Kalpana Dileep Hemmady, a Pedagogist in Chemistry, associated with the Varkey's Gem Foundation in UAE, and brother, Dr. Sameer Dileep Hemmady, a professor with University of New Mexico State, a scientist in Applied Electromagnetics and, founder & Senior Director of his own Scientific research company called "Verus Scientific", provided absolute encouragement, and spurred her to achieve the high goals she had set for herself.

Her success is a testament to the younger Saraswats that "Perseverance and hard work scripts success".



#### INCOME AND EXPENDITURE ACCOUNT

In the FY 2024-25, there is a Deficit of ₹ 10,28,176/- (rupees ten lakhs twenty eight thousand one hundred seventy six only). However, this includes cash loss of ₹ 1,03,425/- & depreciation ₹ 9,24,751/-

The Deficit during the year incurred due to increase of Establishment Expenses from ₹ 9.57 Lakhs in FY 2023-24 to ₹ 15.41 Lakhs in FY 24-25 (i.e. an increase by 61%), due to the ex-gratia amount paid to the Manager KSA on her retirement and legal expenses incurred for clearances of various pending past issues of the Trust at the Hon. Charity Commissioners Office.

The accounts of the Association for the year 2024-25 were finalized and audited by Shri Shriniwas Shreeram Gadgil, partner of M/s P G Bhagwat LLP, the statutory auditor of KSA. Accountancy services were rendered by Shri Sandeep Shrikhande and Shri Aditya Nitsure. Shri Chinmay Nimkar gave GST related service. Smt. Shobhana Rao and Smt. Swati Nadkarni gave efficient support for collating and completing the accounts and for the overall working in KSA office. We immensely thank all of them for their services.

#### CONCISE ACTIVITIES OF KSA VERTICALS IN F.Y. 2024-25

#### Halls & Tenanted property of Association Building

The Structural Audit was conducted and the structural repairs required to be carried out was undertaken. As per the decision of the AGM held in September 2024, the tenants contributed 50% of the total cost towards structural repairs. Most of the work has been completed and the painting is expected to be completed by August/September 2025.

Renovation of both the halls together as well as improving the air conditioning systems of the halls has been undertaken since January 2025. The renovation of The Shrimat Anandashram Hall was completed in April 2025. Members who attended the SGM held in May 2025 in the newly renovated Shrimat Anandashram Hall were appreciative of the work. They also provided the KSA MC with few suggestions on the same. The MC appreciates their invaluable suggestions.

#### Special General Meeting (SGM)

In the 113th Annual General body meeting of KSA a resolution was approved by the members unanimously to undertake Major Structural repairs as per the Structural audit report submitted by M/s. Hi-Tech Consulting Engineers India Pvt. Ltd. During the discussion of this item, it was informed by the Managing

Committee (MC) that when the structural repairs in both the halls will be undertaken, we will assess the repairs work to be undertaken which will include replacement of wall tiles and floor tiles. This would depend on the nature of damage to the structure.

A SGM was held at Shrimat Anandashram Hall, Talmakiwadi, Grant Road on 18th May, 2025 at 10 a.m. for taking ratification and approval of expenses towards the above-mentioned repairs and renovation of KSA Halls and office premises.

The SGM authorised KSA MC to:

- a) Spend upto ₹64 lakhs plus GST towards the repairs and renovation necessitated to both the Shrimat Anandashram and Parijnanashram Halls as well as the office premises in the Kanara Saraswat Association building due to the Structural repairs undertaken
- b) Raise funds through fund raising programs to fund the repairs and the renovation necessitated to the repairs undertaken
- c) Till such time the funds are raised, to use the balances in funds in the balance sheet to meet these emergency expenses

The Minutes of the SGM have been published in the July 2025 issue of the KS magazine.

#### Accounts and Finance Compliances Committee (AFCC)

#### Redevelopment of Talmakiwadi property

The General Body (GB) of Talmakiwadi CHS (TCHS), of which KSA is a member, had passed a resolution in January 2023, to redevelop the property. GB of KSA had agreed in-principle to join TCHS in the Redevelopment. TCHS has unanimously passed a resolution in their SGM held on 27 July 2025 to undertake the Redevelopment with a Developer model and the process for selection of a PMC is currently underway. Mr. Hemant Kombrabail had attended the SGM as a representative of KSA.

Once the details are finalized and approved by the General body of TCHS we will seek approval from the General body of KSA and also present the scheme to the tenants of KSA.

#### Nashik Holiday Home (NHH) & Bhandardara

#### NHH:-

The following has been the occupancy at NHH over the last 5 years. Post the renovation of the New Units, there has been an increase in the occupancy. #### Sale of Bhandardara Plot :-

During the AGM of 2021-22, a resolution was passed with regards to the sale of our plot in Bhandardara (at Survey No. 169/4, Plot No. 41, Village Murshet, Tal. Akole, Dist Ahmednagar). The required permissions were obtained from the Charity Commissioner's Office (CCO) & compliances adhered to towards the sale of the plot. As required by the CCO, two notices were inserted in local newspapers on June 05, 2025 – one in Marathi in 'Sarvamat' & the other in English in 'Free Press Journal'. Quotes were invited till June 20, 2025 in sealed envelopes. Only one quote was received on the last date. On June 22, 2025, the sealed envelope was opened in KSA Conference Room. The quote received was as follows:

As only one quote was received in response to our Notice for Sale, the MC (post taking advice from KSA legal advisor Adv. Ghanshyam Hule), decided to accept the quote for the sale of the plot since the quote received is more than the base price of ₹45 lakhs given in the Notice for Sale, subject to the approval of the CCO & other required statutory/regulatory authorities.

However, KSA received an email dated June 30, 2025 from the bidder Shri Mahesh Deshmukh communicating his decision to withdraw his quote. The KSA committee is in the process of approaching the CCO for the steps to be taken in future.

The same is placed before the AGM for their information.

#### Kanara Saraswat Magazine

During the year under review, the advertisement revenue increased by about 13% to ₹ 15,39,071/-. Due to non-renewal of our RNI, the concessional postage rates still remains withdrawn by the postal authorities we are following up for the RNI Registration with Information and Broadcasting Department of the Governmentt of India. Due to the delay in the RNI Registration we had to bear an extra cost thus increasing the magazine expenses by 12% to ₹ 16,38,904/- and thus a Deficit of ₹ 97,083/- was observed in the Vertical.

During the year we received donations towards the Magazine Fund of ₹ 6,66,278/-, which included ₹ 4,96751/- from Shri Rohit Sthalekar of UK, for the Painting of Param Poojya Swamiji, which was kept at Karla Math during the Shashtyabadipoorthi Utsav at Karla.

#### **SCHEDULE 18: NOTES ON ACCOUNTS**

A Significant Accounting Policies:

#### 1. Basis of Accounting:

The Financial Statements are prepared under the historical cost convention on an accrual basis, except in case of Subscriptions which are accounted on cash basis.

#### 2. Use of Estimates:

The presentation of financial statements requires estimates and assumptions to be made that affect the reported amount of assets and liabilities on the date of financial statements and the reported amount of revenues and expenses during the reported period. Difference between the actual results and estimates are recognised in the period in which the results are known / materialised.

#### 3. Income:

Interest income on Fixed deposits is recognised on time proportion basis taking into account the amount outstanding and the rate applicable.

Income from Rent is recognized based upon the rights given to the tenants against payment of Rent / Lease Fee. The same is recorded on accrual basis in the books.

#### 4. Fixed Assets:

- a. Fixed Assets are stated at cost of acquisition / construction and inclusive of all direct and incidental expenses related to such acquisition / construction.
- b. Cost relating to acquisition of Computer Software is capitalised

#### 5. Depreciation:

Depreciation has been provided at rates as specified under Income Tax Act. Till FY 20-21 the rate of depreciation was prescribed as per management which is changed from FY 21-22.

#### 6. Foreign Currency Transactions:

Transactions arising in foreign currency during the year are recorded at the exchange rates prevailing on the date of the transaction.

#### 7. Contingent Liabilities & Provisions

The Trust recognises a provision when there is a present obligation as a result of a past event that probably requires an outflow of resources and a reliable estimate can be made of the amount of the obligation. Provisions are not discounted to its present value and are determined based on best estimate required to settle the obligation at the balance sheet date. These are reviewed at each balance sheet date and adjusted to reflect the current best estimates. A disclosure for a contingent liability is made when there is a possible obligation or a present obligation that may, but probably will not, require an outflow of resources. Where there is a possible obligation or a present obligation that the likelihood of outflow of resources is remote, no provision or disclosure is made. Contingent assets are neither recognised or disclosed.

#### 8. Regrouping of Funds

The funds are regrouped as given below:

- i) Splitting of Centenary Accrued interest and adding the same to Medical Fund and Education Refundable Grant Fund in the ratio of 30:70
- ii) Emergency Medical Relief fund to be split from the Medical Relief and Emergency Medical Relief fund and merging the fund with Centenary Medical Relief fund as objects for both the funds are same.
- B The Trust has not maintained the Fixed Assets Register as per the requirements of Section 36B and Rule 24A of the Maharashtra Public Trust Act, 1950. The Trust has however, maintained a list of assets and is in the process of compiling the register.
- C In respect of refundable education loans granted by the Trust, there is overdue amount as on 31.3.2024. The Management is confident of recovering this amount.
- D The TDS is paid in excess every year to avoid interest on late payment. The same is adjusted in subsequent years TDS liability.



Summer is the time of year when outdoor events abound. The local parks present performances by music bands every weekend. There are fairs and fiestas on city streets. But the Summer event that Chitra and I have been happily participating every year since it started in 1997, is the Kingsmen Shakespeare Festival that happens on the campus of California Lutheran University ("CLU").

For one thing, the CLU campus is a ten-minute walk from home. Any community event we attend on campus, we meet many of the families who are our neighbors. Two, the campus has huge lawns,

undulating land, and the imposing presence of majestic and noble-looking oak trees. Oak trees are a protected flora species in the city of Thousand Oaks, which named itself after the oak trees scattered liberally across the local landscape. In fact, even if you have an oak tree on your private property,



The Kingsmen Shakespeare Festival chose a part of campus, where the undulating nature of the land provided a nature made theatre setting. The audience can sit comfortably on deck chairs and beach chairs on a gentle slope, watching the play unfold on a temporary stage set up at a lower level.

The festival is presented by the Kingsmen Shakespeare Company, a professional non-profit run by the University. Most of the people organizing the play, are professional stage actors and directors, but the festival is also an opportunity for the students of CLU Theatre and Drama Department to work alongside seasoned professionals. The festival runs for six weekends, three for the comedy play and three for the tragedy.

So, every weekend evening (from Friday evening through Sunday evening) local families attend, along with their extended families and friends. There is a happy, picnic-like atmosphere, with family and friends sharing food, and maybe

meeting after quite a while. It is a small world, and you always run into friends you were not expecting to see at the festival. You hear shouts of delights when these unexpected reconnections happen.

The evening begins with aspiring drama professionals (students in CLU's Theatre and Drama school) offer stand-up comedy, readings from different plays and general entertainment for about an hour prior to the 8:00 pm start of the play. By then, the dusk light is slipping into darkness, even though there is still a bluish

glow in the sky. The stars are beginning to be visible through the canopy of oak trees. Voices slowly ebb in volume as people settle down in their deck chairs in anticipation of the play beginning.

This year, Kingsmen offered, as their tragedy play, "Cymbeline" which is really

a tragicomic play. It is a lesser-known play that Shakespeare wrote and presented at the Globe Theatre in London in 1610. Cymbeline tells the story of King Cymbeline of Britain and his daughter Imogen. Imogen secretly marries Posthumus Leonatus, angering her father and stepmother, who want her to marry Cloten, the Queen's son. Posthumus is banished, leading to a series of deceptions, mistaken identities, and ultimately, reconciliation amidst war and the discovery of Imogen's long-lost brothers. In a way, the play is about second chances. The villain sincerely repents and is forgiven. The King discovers his sons, who were kidnapped as infants. The invading Roman army loses the war, but the victorious British king is in a generous mood, and offers Rome tribute.

The Director of the play attended the book discussion of "Cymbeline" at our local Library. I facilitated this discussion, and asked the Director what he saw as the central theme of the play. He saw "second chances in life" as the central theme of the play and he thought that this theme gave the play its charm and power.

#### **MULTIPLEX WORDS 3**

#### Konkani words with layers of meaning

#### **USHA AROOR**

It is some years since I wrote Multiplex Words 1 and 2. In my mind, I gather words all the time and this seemed a good pause to write down a few more. Many of us know these words and what they mean, so why would I list them out? I thought those who do not, will appreciate the intricacies of Konkani. Those who do will springboard to remembering other words and phrases, and interest will grow.

Although out of humility she didn't want me to mention her, I have been helped so much by Vimala Rao (Hattangadi) with words and phrases that she remembers and which have been somewhat lost in use. We engage in discussing these and often wonder at the origin of some words. Some of the words in the article are from her, with my thanks.

The list of twelve below is largely from speakers of 'tenki'. That was the language I grew up in and use. I welcome corrections and words from readers who use badgi and other varieties of Konkani—or perhaps they can write parallel articles? It would be a learning experience for so many of us and would enrich our store.

#### daakshaN (n) दाक्शन

a hesitation to ask, do etc something because of one's shyness, or a vague fear of being refused.

I felt daakshan (daakshan disley) to ask if I could also go with them in their car as I didn't know them well.

#### thongaN (n) थोंगण

a word indicating disapproval of the way someone is made too much of, fussed over.

He won't help us. He has been brought up with a lot of *thongan*.

#### husko (n) हुस्को

a positive anxiety to ensure that something goes right. 'husko' is an approved emotion.

He feels *husko* (*takkaa husko distaa*) about the meeting going well and so prepares for it carefully.

#### aao che (v) आओंचे

to fill one's mouth with water in order to rinse it and spit out the water, as after a meal or brushing one's teeth. The equivalent phrase is 'ghote bhorche'.

aveet (adj) अवीट

Something which is not considered appropriate for a particular social or religious context is *aveet*.

They came for the prayer meeting in grand, bright clothes and jewellery. It looked *aveet* (aveet disley)

#### aaklas (n) आक्ळस

a fussy, affectionate interest in taking extra trouble with food preparation etc.

They are so kind. They show a lot of *aaklas* when we visit them.

#### bhelshenche (v) भेळ्शेंचे

to go bad and turn in taste.

*Haa<sup>n</sup>v kaaleechi kellel chitni bhelsheli.* The chutney I made just yesterday got spoilt.

#### nevan (n) नेवन

literally - an excuse, but used in the sense of 'lame excuse', an unconvincing reason offered for doing or not doing something.

She loves to drop everything and travel. She just needs a *nevan*! (The Kannada equivalent is *nepa*.)

#### bolonche (v) बोळोंचे

to send someone something

All those clothes boloyeduh (can be sent) to me.

#### kautuk (n) कौतुक

fuss made over someone, often a child, by praising them etc. Sometimes used disapprovingly.

They show the little boy a lot of *kautuk*, he's getting spoilt.

#### kaav (n)

relating to taste - a fresh wave of desire, while one is eating something, to have more of it. Generally used about spicy food.

If I start eating pakoras, *kaav yetta* (I feel like eating more.)

#### mus-mushenche (v) मुस-मुशेंचे

of the body, a vague achy feverishness.

I don't feel well, aang (my body) mus-musheta (feels achy).

#### The Visarjan that Wasn't

Lord Ganesh and I have a cosmic connection. For it is thanks to him I am around to narrate this anecdote.

#### Flashback: May 1975

Shalan and I have just about met when I suggest a picnic at Juhu Beach. Her kid sister, Purnima (Pumi) and nephew Birdie accompany us. This is a picnic with a purpose. To teach Pumi how to swim.

We reach the beach around 10 am. The tide is out. Pumi and I walk briskly across, maybe 200 metres of moist sand. We wave as we wet our toes. Birdie and Shalan are already working on a sand castle. As they wave back, we wade some more until we are waist deep. Pumi gets into her float and begins to follow my instructions. Simple enough.

Keep the body horizontal (the float ensures this). Remember swimming is a rear-engine exercise with the legs being the driving force. And the body and arms parallel to the floor with the latter navigating the direction. And sure enough, Pumi follows suit. She swims towards the horizon and then back, left and then right. This water baby is in her element. And it's time to pat her back. And my own. Mission accomplished. But the story has just begun as the sea sets a higher bar. An element all its very own.

#### Ocean's way

Our pleasant paddle soon turns into a frenetic battle. I reach for the non-existent floor. The sand has apparently slipped from under my feet. I return to Pumi's float. It is now a twin-engine endeavour to return. But it's as futile as moving on a treadmill. You can walk/jog/run a certain distance. Yet be at the same place. Worse, we could even be dragged deeper. For we are trapped in the midst of a civil war. An ocean at odds with itself. The swells are rising higher. And they storm the shore breathing froth and foam. This curtains us from a shore-line we no longer see. For a thousand raging bulls are bellowing land-wards. Yet, we are retreating farther into the sea. Held

hostage by an undercurrent stronger than Pumi's and my futile efforts. At the height of the swell, we see palm trees. The land view is obscured. We scream for help. To no avail in the midst of inner turmoil and external turbulence.

Fortunately, the tide turns. Like a cowboy riding a rodeo, we are tossed landward from our shoulders. While the undercurrent still grabs our heels pointed to the deep. Thus, we somersault our way to the shore. Like clothes in a washing machine: round and round, up and down. Fortunately, the oncoming higher tide prevails over the undercurrent. Our friend Mona Yethiraj was 14 when she focussed her camera on her father and his friends around him in the sea off Marve. In the time she took to click, her dad disappeared forever from the frame, never to return again. The rip tide can be that narrow and strong. Her friends standing close to him, had no clue.

A word of caution: Leave the immersion to specialists. Stay safe onshore. Remember: Time and (rip) tides wait for nobody.

#### With Infinite Gratitude...

Mamta Savkur from USA narrates with great sensitivity how Pujya Swamiji's Compassionate Guidance has stirred devotion, kindled the spirit of seva and enabled every sadhaka to transform ordinary moments into joyous offerings

I still remember with vivid clarity the auspicious Navaratri of 1999, when we first welcomed Pujya Swamiji to Delhi. Purna Kumbha Swagat marked the beginning of a twelve-day period that would leave a lasting imprint on our collective consciousness. The first sight of Swamiji—serene, in simple saffron, seated cross-legged upon a low dais—radiated profound peace and compassion. That moment, though brief, offered a glimpse into the spiritual majesty which was about to envelope our lives.

The Delhi Sabha back then was a modest group, composed mainly of bankers and armed services personnel who frequently relocated. When we heard of Swamiji's visit in May 1999, our small Sabha of about 25 families was filled with a mix of excitement and trepidation. We quickly decided to rent the Kavle Math premises in Greater Kailash-I. It needed significant renovation—from major repairs, installing large water tanks to painting every wall and redoing the entire facility.

Being our first occasion of hosting Swamiji, we were totally inexperienced and unaware of many rituals, poojas, and programme requirements. Our weekly meetings buzzed with questions and logistical challenges, which we resolved through consistent communication with the Bhatmaams at Shirali and the then President. Spiritual preparations—bhajan practices and cultural programme rehearsals—commenced with enthusiasm. Yuvas took charge of decorations and the backdrop, while others worked on logistic details: securing police permissions, arranging generators and PA systems, managing security, parking and also sourcing utensils, tents, fans, and furniture. Seniors, working from home, devoted themselves to packing Bhiksha Prasad and Mantrakshat packets. With only a handful of volunteers, everyone wore multiple hats, offering genuine and joyful seva. Time flew, yet our collective energy soared. Meetings grew frequent, many took days off from work to complete the assigned tasks, spurred on by devotion and excitement.

During this period, the Bhatmaams requested "Patkali flowers" for Navaratri. Unfamiliar with this, and with a long list of pending queries, Naimpally Jayavanth Maam embarked on a journey to Mallapur, where Swamiji was observing Chaturmas. The Bhatmaams not only graciously answered all questions but sweetly packed some "Patkali" flowers as sample. To our surprise and joy, upon its arrival, we discovered it was 'Ixora' – a common garden flower, bringing immense relief and gratitude!

Swamiji's journey to Delhi in 1999 was 'different'- the only time when the travel was by flight. On all subsequent visits, Pujya Swamiji preferred trains or road travel. Senior Sabha members were privileged to greet Swamiji on the tarmac, a cherished experience—made even more memorable as the pilot was my uncle, Capt. Ravi Brahmavar. Those twelve sacred days saw Swamiji perform Devi Pujana, sing soul-stirring bhajans, deliver insightful Ashirvachanas, and give us numerous opportunities for personal interaction. This occasion united our community as "One Large Family," working with unity and bhakti. Our gratitude to Swamiji for this sense of togetherness is beyond words—a bond that only grows fonder with each passing year. It is a testament to Their divine influence that even now, despite many families having relocated to Bengaluru, they still proudly claim to be "Dilliwallas."

After 1999, Swamiji graciously visited us every two years, blessing us with Their divine presence. During this time, Delhi Sabha organized yatras to sacred sites like Chardham, Vaishnodevi and Manasarovar. Despite our move in 2001 to Hong Kong- Singapore and return back to Gurgaon in 2007, I felt an unbroken connection while volunteering for the Saraswati yatra. This was followed by the Tristhali yatra, Kashi, and Badrinath - my last yatra in 2013 before moving to Brazil in 2015 and then coming to US in 2018.



#### Superfoods - H

#### **ANJALI BURDE**

Let us checkout a few super-foods that begin with the alphabet H.

Horse-gram (kulith) - This is an extremely healthy legume being rich in protein and fibre. It is also a very good source of iron, calcium, phosphorus, and potassium. Horse-gram is also a rich source of B group vitamins.

Consumed as a whole pulse it is a popular dal in Kashmiri, Himachali and Punjabi cuisine, and known there as gahat ki dal. It is called kulith in Maharashtra, hurali in Karnataka and kollu parappu in Tamil.

It offers numerous health benefits such as a good metabolism, improved cholesterol levels, better bone health and protection against free radical damage.

Ayurved recommends it for kidney stone prevention and treatment.

Kulitha saar, koddel and upkari are popular amchi dishes. In the North Indian states, it is cooked with onion and tomatoes and served with rice or even stuffed into parathas.

Roasted kulith powder is very popular in the Konkan region of Maharashtra where it is cooked into an aromatic dish called kulthachi pithi or pithla.

Hazelnuts - These nuts have recently gained popularity amongst Indians. Cultivated in the states of Kashmir, Himachal, and Uttarakhand this nut is mostly used as a garnish for desserts and pastries. They are a rich source of healthy fats which help in improving one's lipid profile and thereby support a healthy heart. They are a good source of protein, fibre and a host of vitamins and minerals. Anti-oxidants called phenolic compounds are abundantly present in hazelnuts which could also give them anti-cancer properties. However, like all nuts they are calorie dense and should be consumed moderately.

Honey dew melon - Belonging to the melon family, it is a round melon about the size of a coconut with a pale-yellow rind. The pulp is a pale green to creamy white and is very sweet. The fruit has a high water content, hence a good source of hydration in summer. It is a good source of Vitamin C, potassium and Vitamin B6. It also contains vitamin K and magnesium, which are important for maintaining strong and healthy bones. The high fibre content helps in maintaining a healthy gut.

Hyacinth beans - This a very popular variety of beans widely available in winter and known by various names such as pavta in Marathi, avarekaiu in Kannada and val papdi in Gujarati. The beans are short, flat, broad, and slightly curved. The beans are green in colour but a purple variety is also found. Mostly the outer shell is discarded and the seeds or beans inside are consumed in the fresh or dried form. These are a very good source of protein, phosphorus, potassium, copper, magnesium, and zinc.

By including them in a balanced meal, one can derive numerous health benefits like improved gut health, stronger bones, healthy lungs, stronger muscles, improved sleep, and a strong immune system.

Sharing a recipe called Avarekai sagu which can be eaten with rice, chapatti or puri.

**Ingredients:** 1 cup fresh beans removed from the pods

1 medium onion 2 medium tomatoes

For the masala paste: ½ cup grated coconut 2 tbsp mint leaves

2 tbsp coriander leaves

2-3 medium spicy green chillies

8 cloves of garlic ½ inch piece of ginger ½ tsp haldi 2 tsp dhania-jeera powder

For tempering: ½ tsp mustard 1 sprig curry leaves

½ inch piece of cinnamon 2 cloves

2 tbsp oil

Salt to taste 1tsp of jaggery 2-3 kokum petals or 1 tsp tamarind pulp.

**Method:** Pressure cook the beans for 1-2 whistles. Grind the ingredients for the masala to a fine paste.

Chop the onions and tomatoes.

In a cooking pan heat the oil, add mustard seeds and curry leaves. Let the mustard splutter, then add the cloves and cinnamon. Add the onions and saute till they turn pinkish and transluscent. Add the tomatoes and fry till mushy. Add in the cooked beans and, fry for few seconds then add the ground masala paste. Add some water and adjust the consistency to make a thick gravy. Add salt, kokum and jaggery. Give it a good boil, cover the pan and simmer for a few minutes. Serve hot with rice or chapati.

Charles M. Schulz got it right when he said, 'All you need is love. But a little chocolate now and then doesn't hurt.'

However, we have moved way beyond a little, with humans consuming over 7.5 million metric tons of chocolate each year. That's enough to build a chocolate bridge from Earth to the Moon—with some extra for a 5-Star bar.

July 7 marks World Chocolate Day, the most deliciously unofficial holiday when even dentists look the other way. It is a joyous excuse for chocoholics across the globe to indulge guilt-free. On this day, we celebrate a treat that transcends generations, borders, heartbreaks, diets, and logic (think chocolate-covered insects). But since the world cannot have enough of this treat, America decides to hail choco madness again on September 13, calling it International Chocolate Day.

But how did this sweet sensation become the global icon of indulgence, celebration, and awkward first dates? Let's unwrap this story layer by layer, like a shiny golden foil on your favourite bar.

#### A Bean with a God complex

#### Hindu Calendar Tithis- Navami and Dashami

#### **ANJALI BURDE**

Navami tithi is the ninth day of the month appearing twice as Shukla Navami and Krishna Navami in the waxing and waning fortnights of the month respectively.

Let us learn about some important navami tithis that are observed and celebrated during the year.

**Rama Navami** - this tithi is the ninth day of the Shukla paksha in the month of Chaitra celebrated as the birth tithi of Shree Rama, considered to be the seventh avatar of Lord Vishnu. Born to King Dasharatha and Devi Kaushalya, Rama was the eldest of four brothers namely Lakshmana, Shatrughan and Bharat.

Rama Navami is celebrated with great devotion and fervour across India with the devout fasting and praying. In many temples celebrations begin by placing an idol of baby Rama in a decorated cradle at noon, this is followed by bhajans, kirtanas, rath yatras and palkhi processions. Recitations of the Ramayana and the Rama Charitmanas are organized by the devotees. It is a great celebration in the town of Ayodhya where the temple of Rama Lalla was consecrated on January  $22^{nd}$  2024.

**Sita Navami** - This tithi falls exactly a month after Rama Navami in the month of Vaishakha, the ninth day of the Shukla paksha. This tithi is the birthday of Devi Sita, the consort of Shree Rama. It is also known as Janaki Navami as it was on this day that King Janak had found an infant girl in a golden casket while ploughing a field in preparation of a yagna (ritual sacrifice).

King Janak adopted the infant girl as his child and named her Sita.

Maha navami or Khande Navami - This is the ninth day of the Navaratri festival in the month of Ashwin. This day is significant as there are many rituals associated with it. It is celebrated as the day of Ayudha Puja wherein it is a tradition to worship ones ayudha or instruments of work; e.g. farming tools for the farmer, weapons for the soldier, carpentry tools for the carpenter, brushes for the painter etc.

In contemporary times, computers, laptops and other office tools are consecrated.

According to the Mahabharata, it was on this day that the Pandavas retrieved their hidden weapons from the hollow of the shami tree after

completing their exile and a year of living incognito in the kingdom of King Virata and proceeded to reclaim their lost kingdom from the Kauravas.

Devi Saraswati, the goddess of learning, art and music is also worshipped on this day. Books, slates and pens, musical instruments are placed before the goddess and worshipped. It is also considered to be an auspicious day to begin learning. In earlier days elders would hand-hold little children and make them write on slates thereby beginning their formal initiation into learning (vidyarambham).

**Dashami** or the tenth day of the month falls both in the Shukla paksha as well as the Krishna paksha.

The most widely celebrated dashami tithi is **Vijayadashami** or **Dassera**, which falls on the tenth day of the Shukla paksha of the month of Ashwin. It celebrates the victory of good over evil, be it the vanquishing of the demon Mahishasura by Maa Durga or the slaying of Ravana by Shree Rama, both these events are believed to have taken place on this auspicious tithi.

Dassera is a very auspicious Hindu festival apt for beginning new ventures, shifting into new homes or setting up business establishments. It is also considered as a good day for marriages.

Ganga Dassera - This tithi is widely celebrated in northern parts of India, particularly in the cities of Hrishikesh, Haridwar, Varanasi and Prayagraj through which this holy and mighty river flows. The devout take a holy dip in the river and in the evening a special ritual called Deep daan is performed followed by the Ganga aarti. It falls in the Shukla paksha of the month of Jyestha. It was on this tithi that Ganga is believed to have ascended to the Earth (Gangavtaran) and was held in the matted hair-locks of Lord Shiva.


